21-5225 Use of force in defense of property other than a dwelling [Amends KSA 2010 Supp 21-3213] A person who is lawfully in possession of property other than a dwelling, place of work or occupied vehicle is justified in the use of force against another for the purpose of preventing or terminating an unlawful interference with such property

Developments in the Law - MCADSV - Home

A provision in Missouri law known as "the Castle Doctrine" allows a person who owns or leases private property to use deadly force in self-defense or defense of others against a person who unlawfully enters or attempts to unlawfully enter the property This was expanded in Section 563031 RSMo
