Indeed, legitimacy and effectiveness may trade off each other in the short term: broad participation would secure legitimacy but might hinder rapid decision-making. A monarchy, instead, can lead to very rapid decisions but might totally lack legitimacy. Effectiveness and legitimacy, in fact, are mutually complementary in the long haul.
